Mr. Jurcyk successfully defended the employer and insurance carrier in *Boucher v. Peerless Products*, a Kansas Supreme Court case decision that denied permanent disability to any employee disabled from employment for less than one week. He convinced the Kansas Court of Appeals that fear of AIDS was not a viable cause of action and obtained dismissal of *Reynolds v. Highland Manor, Inc.*

He often argues cases before the Missouri Labor and Industrial Relations Commission, the Kansas Workers' Compensation Board of Appeals, the Missouri and Kansas Courts of Appeals and the Kansas Supreme Court.
