**PPD Benefits in Excess of Impairment** may be granted upon a showing of other factors that will affect a claimant's future earning capacity, e.g., education, work experience.

**Pre-existing Impairment of Function** may be deducted from the final rating.

**Disfigurement** maximum of \$3,500.00 for serious and permanent facial or head.

**Waiting Period for Temporary Total Disability** applies to the first seven days claimant is off work. If disability extends for a period of two weeks, then employer shall pay compensation for the waiting period.
