Temporary Total Disability: The waiting period begins after claimant has missed three workdays. If claimant is off 14 days, then employer must pay TTD benefits for the three-day waiting period.

Medical and hospital treatment: Employee controls choice of physician up to two physicians within the chain of referral. Employer controls choice after the employee's two selections. 820 ILC305/1, Section 8(a)s

Death: Total compensation cannot exceed \$500,000.00 or 25 years of benefits, whichever is greater.

Burial: \$8,000.00

Disfigurement Max: 162 weeks (150 before 2/1/06, excluding 7/20/05 - 11/15/05); Hand, head, face, neck, arm, leg below the knee or chest above the axillary line.

Minimum Rates: either the TTD/PPD minimum OR the claimant's AWW, which ever is lower
