Mileage limited to 250 miles each way.

Medical Allowance No limit.

Pre-existing Disability which was occupationally disabling is deducted from final rating.

Waiting Period for Temporary Total Disability applies for the first three business days claimant is off work. If the claimant is off for longer than 14 days, then the employer must pay TTD benefits for the three day waiting period.

Disfigurement of the head, neck, hands or arms may be awarded at the discretion of the judge (maximum of 40 weeks)

Attorney's Fees and Costs may be awarded to the prevailing party at a Hardship Hearing.
