Mileage will not be paid for trips under 20 miles round trip. Maximum reimbursement is 600 miles per round trip. (Deduction of first 20 miles does not apply to injury dates prior to 8/26/2011)

Non-Soft Tissue/Surgical Injuries after 5/28/19, the Maximum TTD Weeks for non-soft tissue/surgical cases increased from 104 weeks to 156 weeks.
