**Death Benefits** Lump sum payment to spouse and/or children up to \$150,000.00 plus weekly income benefits.

**Burial Allowance** \$8,000.00 if no dependents or heirs-at-law; \$10,000.00 for spouse or dependents  
For injuries 2/1/2014 forward: Burial Allowance is \$10,000

**Pre-existing Impairment of Function** may be deducted from the final rating.

**Disfigurement** when serious and permanent injury on or after 11/01/05, maximum \$50,000.00.

**Mileage** will not be paid for trips under 20 miles round trip. Maximum reimbursement is 600 miles per round trip. (Deduction of first 20 miles does not apply to injury dates prior to 8/26/2011)

For injuries 2/1/2014 forward: TTD starts after claimant has been TTD for three days – no retroactive payment of the first three days.

**Non-Soft Tissue/Surgical Injuries** after 5/28/19, the Maximum TTD Weeks for non-soft tissue/surgical cases increased from 104 weeks to 156 weeks.
